The Council object to this application on the following grounds:  1) The proposal does not meet the following criteria in FNDP Policy D3 1a,b and 6, which states that proposals will only be supported for new residential development including land within the curtilage, or the former curtilage, of private residential gardens, where the proposal makes a positive contribution to the character of the area, in terms of: -the relationship of the existing built form and spaces around the buildings within the surrounding areaa layout which integrates with existing landscape features and the surrounding area, with regards to the built-up coverage of each plot, building line(s), rhythm of plot frontages and parking areasprovides biodiversity net gain and would not have an adverse impact on the biodiversity through the fragmentation of blocks of gardens, which together, or in association with adjacent green spaces or deemed to make an important contribution to biodiversity and the wider green infrastructure network.  2)The proposal also contravenes the TBH special protection area.	19/07/23
