

ROAD TRAFFIC REGULATION ACT 1984

WOKINGHAM BOROUGH COUNCIL

(CALIFORNIA CROSSROADS PROJECT, FINCHAMPSTEAD)

(TEMPORARY PROHIBITION OF DRIVING) ORDER 2024

NOTICE IS HEREBY given that Wokingham Borough Council as Traffic Authority proposes to make an Order under Section 14 (1) (a) of the Road Traffic Regulation Act 1984 the effect of which is to prohibit any vehicle from proceeding along:

1. B3430 Nine Mile Ride, Finchampstead between its junctions with A321 Sandhurst Road to B3016 Finchampstead Road.

The alternative route for all vehicles affected by the restriction contained in 1 hereof shall be via B3016 Finchampstead Road, B3348 Jubilee Road, B3348 The Village, B3348 Fleet Hill, A327 Reading Road, Eversley Road, Langley Common Road, Biggs Lane, Park Lane and Nine Mile Ride Extension or by this route in reverse.

2. Nine Mile Ride, Finchampstead between its junctions with Park Lane to B3016 Finchampstead Road.

The alternative route for all vehicles affected by the restriction contained in 2 hereof shall be via A321 Lower Wokingham Road, B3348 Wellingtonia Avenue, B3348 The Ridges, B3348 Jubilee Road, B3348 The Village, B3348 Fleet Hill, A327 Reading Road, Eversley Road, Langley Common Road, Biggs Lane, Park Lane and Nine Mile Ride Extension or by this route in reverse.

3. B3016 Finchampstead Road, Finchampstead between its junctions with B3348 The Ridges to B3430 Nine Mile Ride.

The alternative route for all vehicles affected by the restriction contained in 3 hereof shall be via B3348 The Ridges, B3348 Wellingtonia Avenue, A321 Lower Wokingham Road, and A321 Sandhurst Road or by this route in reverse.

4. B3016 Finchampstead Road, Finchampstead between its junctions with Barkham Ride to B3430 Nine Mile Ride.

The alternative route for all vehicles affected by the restriction contained in 4 hereof shall be via A321 Sandhurst Road, A321 Lower Wokingham Road, B3348 Wellingtonia Avenue and B3348 The Ridges or by this route in reverse.

5. Warren Lane, Finchampstead between its junctions with Nine Mile Ride and B3016 Finchampstead Road.

The alternative route for all vehicles affected by the restriction contained in 5 hereof shall be via B3016 Finchampstead Road, B3348 Jubilee Road, B3348 The Village, B3348 Fleet Hill, A327 Reading Road, Eversley Road, Langley Common Road, Biggs Lane, Park Lane, Nine Mile Ride Extension and Nine Mile Ride or by this route in reverse.

6. White Horse Lane, Finchampstead between its junctions with Nine Mile Ride and Church Lane.

The alternative route for all vehicles affected by the restriction contained in 6 hereof shall be via Church Lane, B3348 Jubilee Road, B3348 The Village, B3348 Fleet Hill, A327 Reading Road, Eversley Road, Langley Common Road, Biggs Lane, Park Lane, Nine Mile Ride Extension and Nine Mile Ride or by this route in reverse.

7. Range Road, Finchampstead between its junctions with A321 Sandhurst Road and B3430 Nine Mile Ride.

The alternative route for all vehicles affected by the restriction contained in 7 hereof shall be via A321 Sandhurst Road and B3430 Nine Mile Ride or by this route in reverse.

Works requiring this restriction are expected to take place between 12th February 2024 and 1st September 2024.

The reason for these prohibitions is to allow Wokingham Borough contractors to undertake roundabout improvement works in safety.

Access for residents and businesses within the boundaries of these restrictions will be always maintained.

The restriction imposed by the Order shall only apply during those periods when traffic signs complying with the Traffic Signs Regulations and General Directions 2016 are lawfully displayed.

The restrictions contained in the Order shall come into operation on the 12th February 2024 and shall continue in force for a period not exceeding 18 months or until the works have been completed, whichever is the earlier.
